Membership was informed that it was on its last legs and it had been decided not to do any more maintenance on it, when it dies, it dies. Jon Carey will look into a different type of machine more conducive to the cemetery. It would be narrower and can be used on upper half or lower half. He will look into that right away.

Brittany (who lives next door and our water valves are just on other side of the fence on her property) doesn't want anyone on her property anymore. She has someone who is willing to move the lines/valve to cemetery side of the fence. Roberta (Stormi) Peterson will get in touch with TID, it's their decision, to see if they will allow it. She will bring back to the Board and then move forward with Brittany. Until then, Brittany would like to lock the gate and only a couple cemetery people will have that access.

**Increased dues** - Per the letter that went out November 2024 and information put in the annual meeting newsletter, we have raised the membership dues to \$50 annually. This is due to the dwindling/lack of volunteers that come on cemetery clean-up day or are willing to volunteer their time prior to or after that. The Board has had to hire extra help after to finish up weed eating, mowing, etc.

**Elections – Positions open for election are President and secretary.**
